Independent Visitor Training Self Assessment Tool

Guidance on Use of the Self-Assessment Tool

The National Independent Visitor Network is a good practice and influencing platform of in-house and externally commissioned Independent Visitor (IV) schemes operating in England and Wales. The diverse nature of our membership is reflected in the breadth and variety of local IV volunteer training content and delivery. The self-assessment template is intended to be used as a tool to review and evidence progress of IV volunteer training schemes against the nine Training Principles. https://ivnetwork.org.uk/training-principles/ The Training Principles were developed to quality assure and benchmark IV training content and should be read with reference to the National Standards for the Provision of Independent Visitor Services, January 2016.

We recommend the review is conducted by the lead IV Coordinator/ Manager and a senior line manager.

Guidance on providing evidence against core learning outcomes is not intended to be prescriptive but we recommend that evidence is as specific and tangible as possible. Examples of evidence may include:

- Core material included in training content e.g., organisational policy and procedure, thematic research, video clips from those with lived experience, contribution from an established IV and care-experienced young person.
- Delivery style/model e.g., e-learning, take-home assessed work sheets, face-to-face group training, one-to-one training, virtual group training, moderated break-out groups, scenario-based activity, role-play, individual follow-up.
- Duration of training programme
- Participant Feedback eg scaling questionnaires before and after the session to help demonstrate distance of travel.
